- 3. Wasatch Savings Fundraiser October 4-14 Review

    - o Currently there is around \$8,000 in the SCC account
- 4. Parking lot/Safe Walking Route Updates from HPD Let's schedule a time to meet with them either virtually or in person. No reps attended because it was the town meeting night and all reps needed to be at that meeting.
  - **A.** The turning lane into the driveline gets dangerous and patrons are trying to wait to turn and others go around or cut in line. Could cones be utilized to create lanes?
    - a. Yes, it's possible to put cones out onto the road, but there are some hurdles that would need to be discussed such as who is going to put the cones out each morning and each afternoon and gather them back up, who is going to chase down the cones when they get run over, who is going to cover the cost of the cones, and so forth.
